

## **“BET Web of Clues Watch & Win Sweepstakes”**

### **OFFICIAL RULES**

**NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN.**

**OPEN TO LEGAL RESIDENTS OF THE 50 UNITED STATES AND THE DISTRICT OF COLUMBIA (EXCLUDING PUERTO RICO, THE U.S. VIRGIN ISLANDS, AND OTHER COMMONWEALTHS, TERRITORIES AND POSSESSIONS), 18 YEARS OR OLDER.**

1. **HOW TO ENTER:** This sweepstakes begins at 6:00 p.m. ET on April 25, 2014 and ends at 6:00 p.m. ET on May 2, 2014 (“**Sweepstakes Period**”). To enter, watch the BET Network during the Sweepstakes Period for The Amazing Spider-Man 2 question of the day screen graphic, then log on to [www.bet.com/spiderman](http://www.bet.com/spiderman) to correctly answer the daily question. Sponsor (defined in Section 9 below) assumes no responsibility for any computer, technical, telephone, cable, network, satellite, electronic or Internet hardware or software malfunctions, failures, connections, availability, or garbled or jumbled transmissions, or mobile phone carrier/service provider/Internet/website/use net accessibility or availability, traffic congestion, or unauthorized human intervention. Sponsor reserves the right to modify, suspend, or terminate the sweepstakes in whole or in part by giving such notice, in any form and manner deemed appropriate by Sponsor. Should the sweepstakes be modified, suspended, or terminated as aforesaid, the Prize (defined in Section 4 below) will nevertheless be awarded from eligible entries previously received and in accordance with these official rules (the “**Official Rules**”).

2. **ELIGIBILITY:** This sweepstakes is open only to legal residents of the 50 United States and the District of Columbia (excluding Puerto Rico, the U.S. Virgin Islands, and other commonwealths, territories and possessions) 18 YEARS OR OLDER as of April 25, 2014. Employees, and their immediate families (spouses, parents, children, siblings, and their respective spouses), including household members of Black Entertainment Television LLC, Columbia TriStar Marketing Group, Inc. (“**CTMG**”), and their respective affiliates, subsidiaries, divisions, advertising and promotion agencies (collectively, the “**Indemnified Parties**”) are not eligible to enter. 4. **PRIZE:** One (1) winner ("**Winner**") will receive a 4 day/3 night trip for two (2) to the "BET Experience" scheduled June 27-29, 2014 in Los Angeles, California. The prize package includes: (i) round trip coach class airfare from the major gateway airport closest to the Winner's residence and Los Angeles; (ii) hotel accommodations for three (3) nights at a hotel selected in Sponsor's sole discretion (one (1) double occupancy room, room and tax only); (iii) ground transportation while in Los Angeles to and from the airport and hotel; (iv) two (2) tickets to the "BET Awards;" and (v) access to the fan fest events that are free admission and open to the public (collectively, the "**Prize**").
